

ARTICLES OF INCORPORATION  
OF  
MATTHEW KOCHEVAR, P.A.

ARTICLE I  
CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this corporation is Matthew Kochevar, P.A., and the initial principal address of the corporation is 709 West Azeele Street, Tampa FL 33606.

ARTICLE II  
NATURE OF BUSINESS AND POWERS

The general nature of the business transacted by this corporation is to engage in the practice of law and any and all business which a legal professional service corporation is permitted under the laws of the State of Florida and the Rules regulating the Florida Bar.

ARTICLE III  
CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV  
TERM OF EXISTENCE

This corporation shall have perpetual existence.




