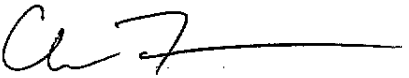

Article I - Name

The name of this corporation is: Christopher McCammon Construction, Inc.

Article II-Purpose

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the state of Florida and the laws of the United States.

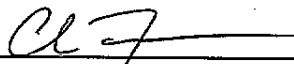
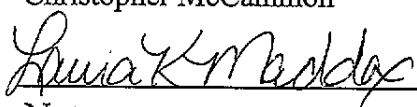
