ARTICLES OF INCORPORATION

Olocal Mass, KIDS WORKS ACADEMY, INC. The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby a corporation under the laws of the State of Florida, effective December 20, 2001.

ARTICLE I

The name of this corporation is KIDS WORKS ACADEMY, INC.

ARTICLE II

The general nature of this business to be transacted by this corporation is child care facilities, related services, and:

- 1. To engage in any activity or business permitted under the laws of the United States and of this State.
- 2. - 3. - 4. To conduct business in, have one or more offices in and to buy, hold, mortgage, sell, convey, lease, or otherwise dispose or real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and countries.
- 5. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.
- 6. To purchase the corporation assets of any other corporation and engage in the same or other character of business.
- 7. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the share of the capital stock of, and any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other state or government, and while owner of such stock to exercise all rights, powers and privileges of ownership, including the right to vote such stock.


