

The name of this corporation is B & B ASSOCIATES OF PASCO COUNTY, INC.





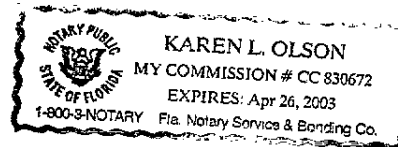
