AMENDMENT

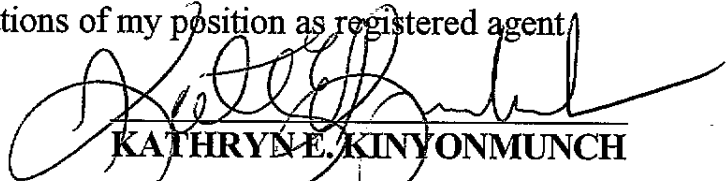
