**ARTICLES OF AMENDMENT
TO THE
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
WOODBIDGE HOLDINGS CORPORATION**

The Amended and Restated Articles of Incorporation, as amended, of WOODBRIDGE HOLDINGS CORPORATION, a Florida corporation (the "Corporation"), are hereby amended pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, and such amendment is set forth as follows:


1. Article VI is hereby deleted in its entirety and replaced with the following:

"Except as otherwise specifically provided in these Articles of Incorporation, this Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation in the manner prescribed by the laws of the State of Florida."

The undersigned hereby certifies that the foregoing amendment was duly adopted and approved by the board of directors of the Corporation on July 28, 2008 and, in accordance with Section 607.0704 of the Florida Business Corporation Act, by the written consent of the holder of outstanding shares of the Corporation's common stock having not less than the minimum number of votes that would be necessary to approve such amendment at a meeting at which all shares of the Corporation's common stock were present and voted. The number of shares of the Corporation's common stock for which written consent was given in favor of the foregoing amendment by the shareholders of the Corporation was sufficient for approval.
