## ARTICLES OF INCORPORATION OF PC GROUP ACQUISITION II, INC.

WE, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of Florida, by and under the provisions of the Statutes of the State of Florida, that provide for the formation, rights, privileges, and immunities of corporations for profits.

#### ARTICLE I

The name of this corporation shall be:

PC GROUP ACQUISITION II, INC.

Its business shall be carried on at Dade County, Florida, and at such other points the Board of Directors may from time to time authorize both within and without the State of Florida or in foreign countries, as may be necessary or convenient. Its principal office shall be at: 145 East 49th St., Hialeah, Florida 33013.

#### ARTICLE II

The general nature of the business or businesses to be transacted is as follows:

SECTION I: To engage in the business of insurance, including but not limited to the Managing General Agency or retail insurance agency operations and financing of insurance premiums.

SECTION II: To engage in any business and to execute any or all the powers authorized and permitted by virtue of the Corporate Law of the State of Florida. This corporation shall have all the general powers, but no recitation, expression, or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive, but is hereby expressly declared that all other lawful powers permitted to corporations for profit are hereby included.

#### ARTICLE III

The maximum number of shares of stock this corporation is authorized to have outstanding at any time shall be 1,000 shares at \$1.00 par value.
