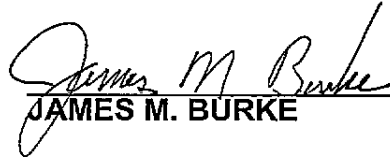

these Articles of Incorporation, or any amendment thereof, and any right conferred upon the shareholders is subject to this reservation.

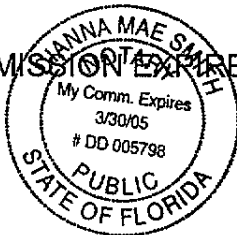

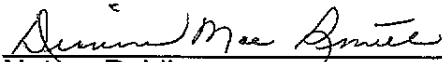

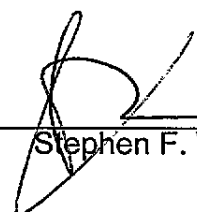
