Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, pursuant to a consent meeting of all of the shareholders and the members of the Board of Directors held January 24, 2002:

Before me, the undersigned authority, personally appeared Cheryl Sassard who after first being duly sworn, deposes and says:


