**ARTICLES OF INCORPORATION

**THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida General Corporation Act, adopts the following Articles of Incorporation with an effective date of January 1, 2002:**

**ARTICLE I**

**The name of the Corporation (hereinafter, the "Corporation") is WALTER C. WILSON III, P.A., whose principal office is 152 Cypress Way East #9, Naples, FL 34108**

**ARTICLE II**

**The purpose of purposes for which the corporation is organized is:**

**To engage in the transaction of any or all-lawful business of brokerage, sales, acquisitions, rentals, and other related activities of real estate, which corporations may be incorporated under the provisions of the Florida General Corporation Act.**
