ARTICLES OF INCORPORATION

We, the undersigned, TIMOTHY E. BRADY and DANIEL P. HIGH, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.

- 1. NAME. The name of the corporation shall be BRADY CONSTRUCTION, INC. a Florida corporation.
