The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation effective January 2, 2002.

ARTICLE I: NAME

The name of the Corporation shall be: WOOD LOVERS, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office of the Corporation shall be located at 5246 U. S.
