THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF

FIRST: The name of the corporation is Jacksonville Architectural Metal, Inc.

FEFECTIVE DATE

The period of its duration is perpetual.

INCORPORATION:

The date of the commencement of the corporate THIRD: existence shall be January 1, 2002.
