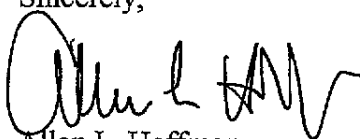

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE: The name of the Corporation is 72 Express, Inc.

ARTICLE TWO: The duration of the corporation is perpetual.
