ARTICLES OF INCORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

NAME

The name of the professional service corporation is Abel A. Putnam, P.A.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS OF THE CORPORATION

The address of the principal office of the corporation is 500 South Florida Avenue, Suite 200, Lakeland, Florida 33801, and its mailing address is P.O. Box 3545, Lakeland, Florida 33802-3545.

ARTICLE III

COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence effective upon the filing hereof and the issuance of corporate stock, and shall exist perpetually thereafter until dissolved according to law.

PURPOSE

The corporation is organized for the sole purpose of rendering professional legal services.

ARTICLE VII BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors. The corporation shall have one director initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation. The name and street address of the initial director who shall hold office until their successors, who shall be chosen at the first meeting of the stockholders have qualified, shall be Abel A. Putnam, 500 South Florida Avenue, Suite 200, Lakeland, Florida 33801.

ARTICLE VIII INDEMNIFICATION

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.
