When issued, all shares of stock shall be fully paid and nonassessable.

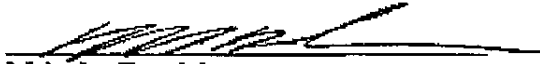
4. The correction to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article IV of the Articles of Incorporation as of the date hereof,
