ARTICLES OF INCORPORATION OF

RISING STAR APPRAISAL SERVICES, INC.

The undersigned Incorporator to these Articles of Incorporation is a natural person competent to contract hereby forms this corporation under the laws of the State of Florida.

ARTICLE I

NAME
