ARTICLES OF INCORPORATION  
OF

VICTORIA P. BEHM, P.A.

In compliance with the requirements of F.S. Chapter 607, undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Professional Corporation ("Corporation") is VICTORIA P. BEHM, P.A.

ARTICLE II

The Corporation is formed for the purpose of conducting the practice of law and the existence of the Corporation shall begin on the date of filing of these articles.

ARTICLE III

The street address of the principal office of the Corporation is 405 2<sup>nd</sup> Street South, Suite C, Safety Harbor, Florida 34695

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000 par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

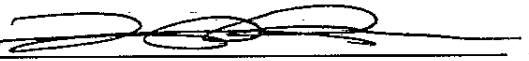
The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
