Dear Mr. Smith,

I recently received a letter of notification that my corporation, FLORIDA ANGEL, INC., had been dissolved due to failure to file by the due date of May 1, 2002. I am writing this letter of explanation in an attempt to resolve and reverse this dissolution.

In January, 2002, I received and notice for the annual filing, and mailed a check in the amount of \$ 150.00 to the Division of Corporations. As you review the documentation in the corporation file, you will see that I do not remember receiving the notice, nor sending the check to your office. It was, however, sent and received within the due date for the correct amount. Subsequently, a document specialist by the name of Barbara Mitchell informed me in October 2002 that since I had not sent the corrections to the form, that an additional filing fee of \$ 550.00 was owed. It was unclear to me at that time what corrections were needed. I was informed that the FEI Number was not included on the original form. This error was a misunderstanding on my part. I incorrectly assumed that the number would be sent to you by the federal government as it was assigned to the corporation. I subsequently sent another check in the amount of \$ 150.00.

During the past two years, I have suffered a number of "mini- strokes", causing substantial short- term memory loss. I have great difficulty in keeping track of recent events, although my long -term memory is excellent.

I am requesting your indulgence in this matter, as the original check was lost by your department and not even identified until October 2002. If the filing fee had been properly credited, perhaps there would not have been so much confusion, and filing would have been completed in a timely manner.

I am also requesting that you credit the extra \$ 150.00 toward the fee for 2003, which would be due by May 1st for an active corporation. It is my earnest wish to file all forms in a timely manner in accordance with the corporate laws in Florida, and I plan to take steps to insure that this is done correctly in the future.
