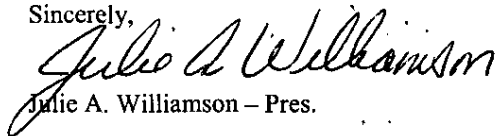
Dear Department of State,
