ARTICLES OF INCORPORACION OF CFI, CENTRAL FLORIDA INVESTORS, INC

The undersign subscribers to these Articles of Incorporation, desiring to farm a Corporation under the laws Of the States of Florida, do hereby adopt the following.

Articles of Incorporation as the charter of the corporation hereby organized.

ARTICLE I

NAME: The name of this corporation is:

CFI, CENTRAL FLORIDA INVESTORS, INC

ARTICLE II

<u>DURATION:</u> This Corporation shall have perpetual existence, commencing upon the date of these Articles of Incorporation with the Department of State, State of Florida.

ARTICLE III

<u>PURPOSE</u>: This Corporation is organized for the purpose of investing in Real State Rental Properties, Whole Sale of Vehicles, and any opportunity of investment thereafter.

<u>ARTICLE IV</u>
