**ARTICLE I NAME**The name of the corporation shall be: **Central Florida Controls, Inc.****ARTICLE II PRINCIPAL OFFICE**The principal place of business and mailing address of this corporation shall be:  
726 Marion Oaks Ln., Ocala, Florida 34473**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is: Central Florida Controls provides calibration, maintenance and repair services for various instrumentation and controls used in public utilities and industry. A brief description of instrumentation would be anything that measures, indicates, or records things like pressure, temperature, level, or flow. An example would be a flow meter that measures the amount of water pumped from a well by a public utility. The utility would also monitor and record the water pressure in the distribution system with a pressure transmitter and chart recorder. A manufacturer of plastic injection type parts would measure and control the temperature of the ovens or molds. Central Florida Controls calibrates the instruments (certify that the readings are correct), performs preventative maintenance, and repairs defective equipment. We also provide installation and resale of new equipment.

**ARTICLE IV SHARES**
