**ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be **Country Haven Mobile Home Park, Inc.**

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address shall be 3759 Mackey Cove Drive, Pensacola, Florida 32514.

**ARTICLE III
PURPOSE**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States or the State of Florida.

**ARTICLE IV
DURATION**

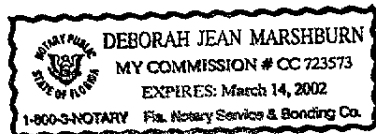
