ARTICLES OF INCORPORATION

OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporation in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is The Bick Shop of Boynton Beach, Inc.
