ARTICLES OF INCORPORATION OF FIRST AMERICAN NESV, INC.

The undersigned, acting as incorporator of this Corporation pursuant to Chapter?

607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of
Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be First American NESV, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 1983 Centre Pointe Boulevard, Suite 100, Tallahassee, Florida 32308, which shall also be the mailing address of the Corporation.

<u>ARTICLE III - CAPITAL STOCK</u>

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock having a par value of One Cent (\$.01) per share.

ARTICLE IV - INITIAL REGISTERED OFFICE AND REGISTERED AGENT
