***Articles of Incorporation
of

Article I – Name

The name of the corporation is: George Harris Enterprises, Inc.

Article II – Duration

This corporation shall exist perpetually.



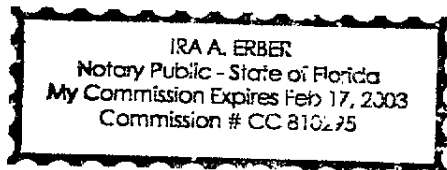
