The undersigned, acting as incorporator of **INSIGHT CORPORATE CONSULTING, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be **INSIGHT CORPORATE CONSULTING, INC.**

ARTICLE II - EXISTENCE

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III - ADDRESS

ARTICLE IV - PURPOSE
