Thank you for your letter dated November 30, 2004. It again, was not sent to our new address which was clearly written on Document # PO1498 sent with my last letter to your office. The address on that Document form was given as it is given on this stationary. September 2004 we moved our communications office to Reno Nevada. (See copy of PO1498 attached along with your letter to me and copies of other documents you returned with it).

Since your November letter was not forwarded by postal staff to the Nevada Office until mid December. I called your office today to find out what is really needed because everything I originally sent to you was returned again to the Rancho Dominguez address except a copy of my original letter which is now in storage in California and I will not be in that state for at least three months.
