This letter is to notify you that we have changed the name of our 501 (c)(3) Tax Exempt non-profit from "Concerned Businessmen's Association of America" to "Set A Good Example Foundation." We want to let you know this. Our current EIN is 95-3658314.

There are several reasons for making this name change.

1. For 25 years we have used this organization to forward nationally the Set A Good Example Campaign and Student Competition to help reduce drug abuse, crime, violence, illiteracy. Thus changing the name of our 501 (c)(3) to Set A Good Example Foundation works well. The question is:
2. Gender questions are received too often wanting to know why this organization is not called Concerned Businesswomen, or Concerned Businesspeople, or Concerned Businesspersons Association of America. We are handling that by creating a new non-profit (not a Tax Exempt) corporation titled the "Association of Concerned Businesses."
3. We are also incorporating another 501 (c)(3) tax exempt organization named ACB Foundation. This foundation is a public benefit corporation dedicated exclusively to non-political, non-partisan, non-religious, charitable/educational activities that help improve society.
