The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 621, Florida Statutes, and all other applicable law, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the professional service corporation ("corporation") is Law Offices of Michael W. Udowychenko, P.A.

ARTICLE II – PRINCIPAL PLACE OF BUSINESS

The corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.


ARTICLE IX - INDEMNIFICATION
