ARTICLE I-NAME

The name of the corporation is M & A Exports, Inc..

ARTICLE II-DURATION

The corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

ARTICLE III-PURPOSE
