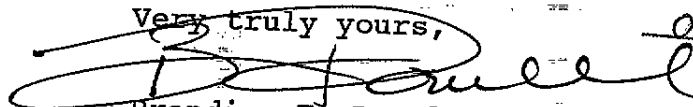

- ARTICLE I: The name of this corporation is **Pure Bliss, Inc.**
- ARTICLE II: The existence of the corporation shall begin January 1, 2001.
- ARTICLE III: The principal place of business of the corporation shall be 505 N.E. 20th Ave, #212, Deerfield Beach, Florida 33442.
- ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares.
