ARTICLES OF INCORPORATION OF GALLANT REALTY SERVICES, INC.



The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is: Gallant Realty Services, Inc.

ARTICLE II - Principal Office and Mailing Address

The street address of the initial principal office and mailing address of the corporation is 2028 Blais Avenue, Daytona Beach, Florida.

ARTICLE III - Nature of Business

The general nature of the business to be transacted by this corporation is realty services.
