*The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation.*

**ARTICLE I NAME**

The name of the Corporation shall be: GOLDA, ENTERPRISES, INC.

**ARTICLE II PRINCIPAL OFFICE**
