ARTICLE I NAME

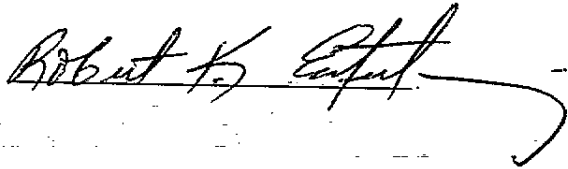

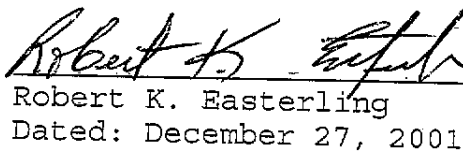
