The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I.

**NAME:** The name of this corporation shall be PLATINUM PRODUCTIONS SERVICES, INC.

ARTICLE II.
