ARTICLES OF INCORPORATION

The undersigned incorporator, being a natural person competent to contract for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The Corporate name is: **Chiliheads, Inc.**

ARTICLE II

The initial street address and mailing address of the principal place of the Corporation is: 1427 Corner Oaks Drive, Brandon, FL 33510.

ARTICLE III

This Corporation shall commence and be effective on January 1, 2002 and shall exist perpetually.

ARTICLE IV

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.

ARTICLE V

This Corporation is authorized to issue 10,000 shares of \$ 1.00 par value, common stock. The rights attendant to all such shares, once issued, shall be identical in all respects. The shares of this Corporation are not to be divided into classes. This Corporation is not authorized to issue shares in series or in less than whole shares.

ARTICLE VI

Every Shareholder, upon the issuance of any new stock of this Corporation, shall have the right to purchase his or her pro-rata share thereof (as nearly as can be done without issuing fractional shares), at the price at which it is offered to others.

ARTICLE VII

The initial street address and mailing address of the principal place of the Corporation is: 1427 Corner Oaks Drive, Brandon, FL 33510. The initial address in Florida of the initial Registered office of this Corporation is: 1427 Corner Oaks Drive, Brandon, FL 33510; and the name of the initial registered agent of this Corporation at that address is: Eugene Ramos.

ARTICLE VIII

The business of the Corporation shall be managed by a Board of Directors consisting of a minimum of one director and a maximum of seven directors. the number of Directors may be either increased or diminished from time to time by the Shareholders, but shall never be less than one. The initial Board of Directors shall consist of one Director, who shall serve as Director until the first annual meeting of the Shareholders, or until successors have been elected and qualified, and whose name and address is: Eugene Ramos 1427 Corner Oaks Drive, Brandon, FL 33510.

ARTICLE IX

The President shall be Eugene Ramos.

ARTICLE X

The Shareholders of this Corporation shall adopt By-Laws which shall contain provisions for the management of the business and the regulation of the affairs of the Corporation that are not inconsistent with the Articles or the laws of the State of Florida.

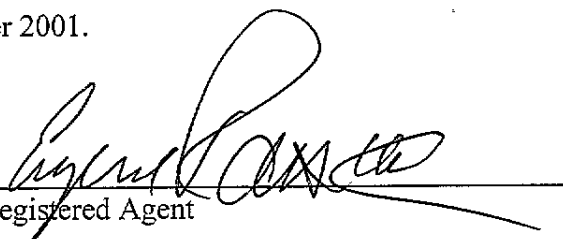
