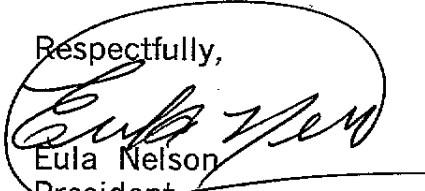

**ARTICLE 1- NAME**

The name of the corporation is: **T's Shear Elegant Salon, Inc.**

**ARTICLE 2 - PRINCIPAL OFFICE**
