

ARTICLES OF INCORPORATION
OF
SUN-TEC PAPER & CHEMICALS, INC.

ARTICLE I - Name

The name of this corporation is SUN-TEC PAPER & CHEMICALS, INC.

ARTICLE II - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - Capital Stock

This corporation is authorized to issue 100 shares of One Thousand Five Hundred (\$1,500.00) Dollars par value common stock.

ARTICLE IV - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V - Initial Registered Office and Agent

The street address of the initial registered office, the principal office, and the mailing address of this corporation is 28790 S. ARTICLE VI - Initial Board Of Directors

This corporation shall have five directors initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE XII - Compensation


