**NAME**

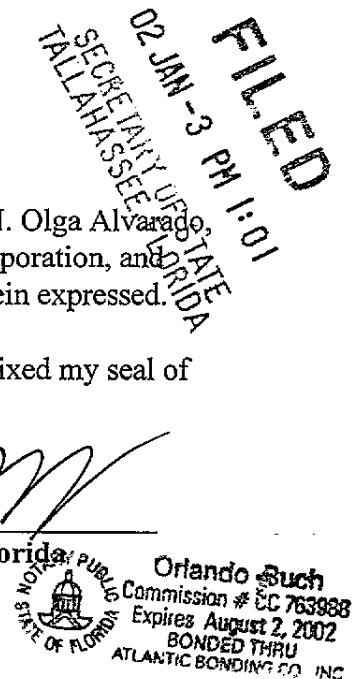
