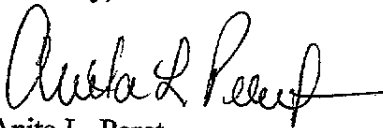

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Sun Coast Service Corp. The mailing and street address of the principal office of the Corporation is 15912 Old Stone Place, Tampa, FL 33624.

ARTICLE II

The Corporation shall have perpetual existence, commencing on January 2, 2002.

ARTICLE III

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one thousand (1,000), par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is Gail Martin Abercrombie, P.A., 1304 DeSoto Avenue, Suite 203, Tampa, Florida 33606. The initial registered agent for the Corporation at that address is Gail Martin Abercrombie, Esquire.

ARTICLE VI
