ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is ANCLOTE FIRE & SAFETY, INC., and the principal address and principal place of business is 1332 NORMANDY BOULEVARD, HOLIDAY, FLORIDA 34691.

ARTICLE II - REGISTERED OFFICE AND AGENT
