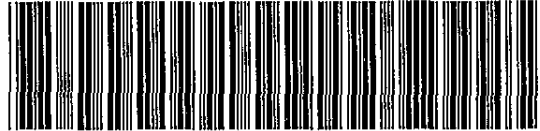

Pursuant to the written consent of the voting shareholders of the Corporation, in lieu of a special meeting, which vote was sufficient for approval, the following resolution was adopted on July 18, 2003, amending the Articles of Incorporation:
