## ARTICLES OF INCORPORATION

OF

FIRST. The name of the corporation is Dynamix Specialty Distributors, Inc.

SECOND. The street address of the initial principal office of the corporation is 2901 Eunice Ave., Orlando, FL 32808.

THIRD: The total number of shares of all classes of stock which the corporation shall have authority to issue is 4,000 of which 2,000 shares of par value \$1.00 per share shall be designated as Common Stock and 2,000 shares of par value \$1.00 shall be designated as Preferred Stock. 
