**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Pride Network, Inc. Its principal office address and business mailing address is 1975 East Sunrise Boulevard, Suite 825, Fort Lauderdale, Florida 33304.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**


