
A Notice of Intent to Dissolve on September 16, 2004 was just received by the above Corporation. However, the Uniform Business Report for this Corporation was filed and paid online on 06/18/04. I am enclosing a copy of the Receipt that was generated at the time as well as copies of all the other paperwork from the filing. You will note that this paperwork indicates payment to a credit card as well as a Tracking Number.

When I telephoned Tallahassee concerning this situation, I was told to complete a Corporation Reinstatement (enclosed) and also provide proof of the credit card charge for \$150.00. Unfortunately, our search for this paperwork has been futile and we are unable to provide proof that this charge was ever actually put on the credit card. Evidently this was never processed and, therefore, CTM-Kool, Inc, was left in limbo. As far as we knew, this report was taken care of months ago so we were astounded to be notified of the Dissolution! Therefore, we are requesting that the Corporation be reinstated for the original fee that **WOULD HAVE** been paid if the charge had been processed. It would create an undue hardship for my client to have to pay any additional fees because of this snafu and, in light of these circumstances, it would certainly seem grossly unfair.
