ARTICLES OF INCORPORATION

OF

CHRISTINE BENDER MILLER, P. A.

Pursuant to the provisions of the Professional Services Corporation Act of the State of Florida the undersigned Christine Bender Miller, being a duly licensed real estate agent does hereby make, organize and form a professional service corporation under the following Articles of Incorporation to wit:

ARTICLE I - NAME

The name and address of the corporation is:

ARTICLE II - DURATION

The corporation shall have perpetual existence. This corporation's existence shall commence on the date of execution and acknowledgement of these articles.

ARTICLE III - PURPOSE

The general nature of business to be transacted in this corporation is:

1. To provide to the public those professional services rendered by real estate agents duly licensed under the laws of the State of Florida in accordance with the terms and provisions of the Professional Service Corporation Act of the State of Florida
2. To invest its funds in real estate, mortgages, stocks, bonds, or other types of investments and to purchase, encumber, and convert real and personal property necessary for the rendering of professional services and to do all and everything necessary and proper for the accomplishment of the purposes and objectives of said corporation.
3. In addition to the foregoing powers, this corporation shall have all the general and additional powers and authority granted to professional service corporations under the laws of the State of Florida.

ARTICLE IV- CAPITAL STOCK

The total number of shares of Capital Stock which the corporation shall be authorized to issue is ten thousand (10,000) shares. Such shares shall be a single class of common stock and shall have a par value of one (\$1.00) dollar per share.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder upon the sale of any new stock of this corporation of the same kind, class, of series as that which they already hold, shall have the right to purchase their pro-rata share thereof as nearly as may be done without the issuance of fractional shares at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1820 Lake Emma Rd., Longwood, Florida, 32750, and the name of the initial registered agent of this corporation at that address is Christine Bender Miller.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

The corporation shall have one (1) director initially. The number of directors may either be increased or diminished from time to time by the bylaws but shall never be less than one (1). The name and address of the initial director of this corporation is:
