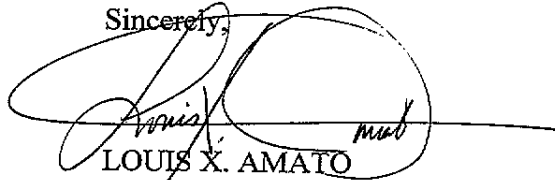

**ARTICLE I

**OFFICERS AND DIRECTORS**

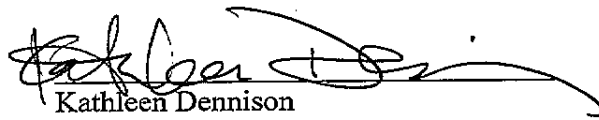

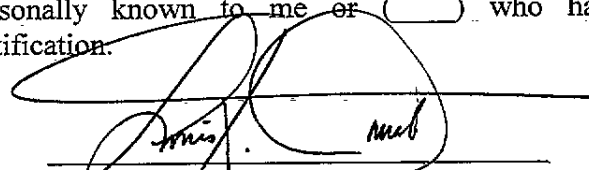

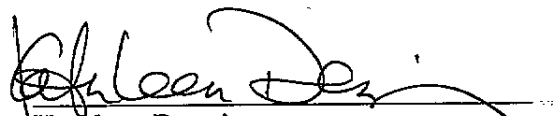
