ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of BERNARDO ACEBEDO CONSTRUCTION, INC. under the Florida General corporation Act, adopts the following articles of Incorporation.

ARTICLE I. NAME

THE name of the corporation is: BERNARDO ACEBEDO CONSTRUCTION INC. the principal place of business of this corporation shall be; 11233 S. W. 190 st. miami fl, 33157

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of receipt and acknowledgement of these Articles of Incorporation.

ARTICLE III. PURPOSE

THE nature of the business or purpose to be conducted or promoted is to engage in any and all lawful act of General Cooperation Law of Florida, including without limitation the ability to and engage in all other matters incident thereto.

ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is 10,000 authorized to have outstanding at any time is 9,000 shares of common stock having a par value of \$ 1.00 per share. the consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of directors. equivalent to or greater than the full par value of the shares.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI. INITIAL BOARD OF DIRECTORS

The corporation shal have one (1) director initially. the number of directors may be increased from time to time, as provided in the bylaws, but never less than one. The name and street address of the initial directors is; Bernardo A Acebedo.

ARTICLE VIII. BYLAWS

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaws adopted by the shareholders if the shareholders specifically provide that the bylaws are not subject to amendment or repeal by the directors.
