ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SOUTH FORK RANCH TREE FARM, INC., and the principal address and principal place of business is 5645 SOUTH FORK RANCH ROAD, CLERMONT, FLORIDA 34711.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI - AMENDMENTS




